



MINOR PERMISSION FORM
ASSUMPTION OF RISK, RELEASE FROM LIABILITY AND AGREEMENT

(Revised July 1, 2003)

1. I/We hereby give my/our permission for my/our minor child, _____, to participate in construction and other volunteer services at this project/site: _____, under the auspices of San Diego Habitat for Humanity (SDHFH).

2. I WE/ARE AWARE THAT CONSTRUCTION IS A HAZARDOUS ACTIVITY. MY/OUR CHILD VOLUNTARILY PARTICIPATES IN THESE CONSTRUCTION ACTIVITIES WITH THE KNOWLEDGE OF THE DANGER INVOLVED AND WITH THE KNOWLEDGE THAT MEDICAL FACILITIES MAY NOT BE AVAILABLE IN THE EVENT OUR MINOR CHILD WAS INJURED. I HEREBY AGREE TO ACCEPT ANY AND ALL RISKS OF INJURY OR DEATH, AND VERIFY THIS STATEMENT BY PLACING MY INITIALS HERE: _____.

3. As consideration for being permitted by SDHFH or one of its affiliates or a company making a contribution of land, labor or materials to SDHFH, to participate in these activities and use their tools, facilities and/or materials, I hereby agree that I, my heirs and assigns, guardians, and legal representatives will not make a claim against, sue, or attach the property of SDHFH, or any of its affiliates or companies making a contribution of land, labor or materials to SDHFH, for injury or damage resulting from the negligence or other acts or omissions, howsoever caused, by any employee, agent, volunteer, contributor or other acts or omission I will use in these activities, for injury or damage resulting from the negligence or other acts, howsoever caused, by any employee, agent, contributor or other participant in SDHFH activities. I also agree to abide by all rules and accepted construction and safety practices while participating in SDHFH activities.

4. I acknowledge that I am familiar with and understand the provisions of California Civil Code (CCC) Section 1542 which provides as follows: "A general release does not extend to claims which the creditor does not know or suspect to exist in its favor at the time of executing the release, which if known to him must have materially affected his settlement with the debtor." I/we hereby freely and expressly waive and relinquish each and every right and benefit which I may have or have in the future under CCC Section 1542 to the fullest extent permitted by law.

5. I hereby grant and convey unto SDHFH all right, title and interest in any and all photographic images and video or audio recordings made by SDHFH at Habitat's project/site as indicated in Item 1.

6. I/WE HAVE CAREFULLY READ THIS ASSUMPTION OF RISK, RELEASE FROM LIABILITY AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I/WE ARE AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND SDHFH AND THAT AFFILIATES OF SDHFH AND VOLUNTEERS AND CONTRIBUTORS OF SDHFH ARE THIRD PARTY BENEFICIARIES OF THIS CONTRACT.
